NOTICE FROM THE CLERK

YOU ARE HEREBY NOTIFIED, pursuant to Fla. Stat. § 205.053, §162, and Palm Beach County Municipal Code, Chapter 17 that a Petition has been filed by ANNE M. GANNON as Constitutional Tax Collector, Palm Beach County, Florida, and that upon ratification and confirmation of the Petition, the Tax Collector will be authorized to issue warrants and levy upon, seize, and sell so much of the tangible personal property as to satisfy the delinquent taxes, plus costs, interest, attorney's fees, and other charges. The Petition, including Exhibit "A", is located on the Tax Collector's public website at www.pbctax.com and relates to unpaid business tax receipts for tax year 2016. Please read the Petition as it may impose additional penalties and affect your ability to operate your business. You have twenty (20) days from the date of receipt (service) of this Notice to respond to the Petition.

Please note there are two (2) court hearing dates scheduled in this matter. The purpose of the first hearing scheduled for **June 28, 2017 at 8:30 a.m.** is to seek court approval to **Limit Service of Pleadings**. The Final Hearing on the **Petition for Validation of the Business Tax Receipts ("BTR") Tax Warrants** is being held to ratify the BTR warrants and is scheduled for **August 11, 2017 at 11:30 a.m.** at the Palm Beach County Courthouse, 205 N. Dixie Highway, Courtroom 11B, West Palm Beach, Florida. 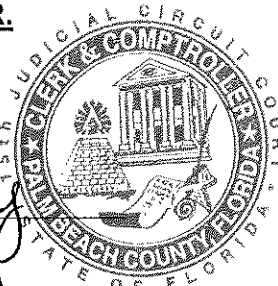
