**YOU ARE HEREBY NOTIFIED**, pursuant to Fla. Stat. ch.197.413 (5), that a Petition has been filed by ANNE M. GANNON as Constitutional Tax Collector, Palm Beach County, Florida, and that upon ratification and confirmation of the Petition, the Tax Collector will be authorized to issue warrants and levy upon, seize, and sell so much of the tangible personal property as to satisfy the delinquent taxes, plus costs, interest, attorney's fees, and other charges.
